LOCATION OF PLAY: Tournament headquarters will be at 325 S. La Cienega Blvd in Beverly Hills.

ENTRY DEADLINE: Entries must be received by APRIL 9TH, 2010. Fees must accompany entry form. Make check payable to **Beverly Hills Tennis**. Send doubles entries together.

REFUNDS: There will be no refunds unless a specific division/event is cancelled due to lack of a minimum number of entries, and at the tournament committee's discretion.

RULES/SCORING: U.S.T.A. Rules will govern play. For Adults regular scoring will apply. For Jr.'s a third set tie-breaker will be played in lue of a third set.

CLASSIFICATION-JUNIORS: For juniors who (1) have not won more than two rounds in an Open USTA Junior Tournament or (2) who have not won 3 or more Satellite Tournaments with at least 3 rounds (excluding defaults) in their age division or (3) have never been ranked by the USTA in any age division.

Refer to the following age eligibility chart for April Tournaments:

- 10 & Under - Born on or after 5/1/98
- 12 & Under - Born on or after 5/1/96
- 14 & Under - Born on or after 5/1/94
- 16 & Under - Born on or after 5/1/92
- 18 & Under - Born on or after 5/1/90

You are responsible for entering yourself in the correct age division.

CHECK - IN/DEFAULT: Players should check-in at least 15 minutes before all scheduled matches. A strict 15 minute default time after the specified time of a scheduled match will be enforced unless no courts are available at the time of the match.

AWARDS: Trophies will be awarded to the finalists in all events.
